



ÅRSBERÄTTELSE FÖR ÅR 2014

Styrelsen och styrelsearbetet. Styrelsen för ICOMOS SVERIGE har under året bestått av Nils Ahlberg, ordförande, Malin Myrin, vice ordförande, Jan-Gunnar Lindgren, sekreterare, Daniel Kwiatkowski, kassör, samt de övriga ledamöterna Staffan Hansing, Jan Melander och Lena Palmqvist. Det har hållits sju styrelsemöten, i de flesta fall i form av halvdagslånga arbetsmöten, och även mindre ledningsmöten. Styrelsen har därtill fortlöpande kontakter sinsemellan och med medlemmar per e-post och telefon i enskilda frågor.

Medlemmar. Föreningen hade vid årets slut 165 individuella medlemmar, 17 institutionsmedlemmar och 2 hedersmedlemmar.

Medlemsstruktur. Under året har ett arbete initierats för att få en mer representativ spridning av medlemskåren över landet till alla yrkesgrupper och olika ålderskategorier. För att komma vidare i denna strävan avser vi att inom styrelsen utse en av ledamöterna att särskilt ansvara för medlemsrekrytering.

Internationella kommittéer och svenska arbetsgrupper. Under året har flera medlemmar deltagit i möten med de internationella vetenskapliga kommittéerna på olika håll i världen. Bl.a. kan nämnas kommittéerna för *Theory and Philosophy* och *Wood*. En svensk medlem har deltagit i en omorganisation av kommittén för *Rock Art*, som under en period saknat verksamhet, och ingår nu i dess styrelse. En lång rad möten med kommittéerna ägde rum under generalassemblén. I Sverige har två särskilda träffar för representanterna, kombinerade med seminarium eller studiebesök, anordnats under 2014.

Föreningsaktiviteter och informationsutbyte. I samband med årsmötet genomfördes ett seminarium om arbetet i världsarvskommittén, i vilken Sverige varit representerat under många år genom förra riksantikvarien Inger Liliequist. Tillsammans med Birgitta Hoberg svarade hon för detta uppskattade seminarium. I samband med träffen med de representanterna i de internationella kommittéerna genomfördes ett studiebesök i Uppsala domkyrka och restaureringen av dess målade fönster. I anslutning till *International Day of Monuments and Sites* och årets tema *The Heritage of Commemoration* genomfördes under april ett välbesökt studiebesök på Norra kyrkogården i Stockholm.

Arbetet att förbättra informationen till medlemmarna har bl.a. inriktats på att utveckla hemsidan mot större tydlighet och därmed användarvänlighet. Detta arbete fortsätter under 2015. Vi gör också fler separatutskick av konferensinbjudningar och information än tidigare.

Internationellt samarbete. Vid årets möte med *Europe Group*, i Strasbourg i slutet av juni, diskuterades bl.a. samarbetet med Europarådet och EU, olika aktuella världsarvsfrågor, kulturarvet i den ekonomiska krisen och aktuella frågor i de olika länderna.

Generalassemblén i Florens i början av november var årets stora aktivitet. Den föregicks av möten med *Advisory Committee* och *Scientific Council*. En del av assemblén tar upp administrativa och doktrinära frågor samt val av förtroendeposter, och en del består av ett stort symposium med fem parallella sessioner. Det övergripande temat var ”*Heritage and Landscape as Human Values*”. Från svensk sida deltog så många som 21 medlemmar av vilka 12 erhöll resestipendier för att göra deltagandet möjligt. Flera medverkade i seminarier med presentationer och med posters. Vi anordnade också ett eget möte med våra nordiska och baltiska kolleger. Det kan särskilt noteras att ICOMOS SVERIGEs ordförande, Nils Ahlberg, valdes in i *Executive Committee* för en period av tre år.

ICOMOS SVERIGE har under året deltagit i arbetet att bilda en svensk Blue Shield organisation. Syftet med denna är att skydda kulturarv som hotas av krig och naturkatastrofer. Under 2015 kommer denna att tas upp i den internationella organisationen.

Världsarvsfrågor och frågor av principiell karaktär. ICOMOS har under året i såväl skrivelser som underhandsdiskussioner gett synpunkter på utvecklingen i flera världsarv. Vi har sett att, samtidigt som världarven uppfattas som en stor tillgång främst för besöksnäringen, är de på sina håll utsatta för ett starkt förändringstryck främst av storskaliga vindkraftsanläggningar. ICOMOS har länge efterfrågat en bred analys av förutsättningarna för att bevara och utveckla världarven, för att därigenom få ett underlag för en diskussion om hur Sverige än bättre än i dag kan ta till vara den stora tillgång som världarven utgör.

Nationellt samarbete. ICOMOS SVERIGE har fortlöpande kontakt med andra organisationer på kulturarvsområdet, så som Svenska Byggnadsvårdsförening, Europa Nostra, Svenska industriminnesföreningen, ICOM, den nygrundade organisationen Kulturmiljöfrämjandet, m.fl. Det gäller deltagande i möten, och allmänt informations- och erfarenhetsutbyte. Via våra medlemmar och institutionsmedlemmar samarbetar vi också med organ som Boverket, Svenska kyrkan, olika universitet och museer.

Ytterligare detaljer finns i den *Annual Report* som ska skickas in till ICOMOS International. Den innehåller, förutom styrelsens arbete, de uppgifter som kommit in från medlemmarna i februari 2015.
